# C. ADDITIONS TO/APPROVAL OF AGENDA

Damon motioned to change Agenda letter I to read "Appoint one person to fill one of the vacancies left by the resignations of Melanie Freedle, and Eryn Wintz", John Howard seconded, all approved in alphabetical order.

#### D. CITIZEN'S COMMENTS

Tim Bachicha – Tim just introduced himself.

Kassidy Mankowski – She just wanted clarity on the term limits and the order they would be filled, but her questions had been answered. Term limits are not a law in Mineral County.

Dave Robinson- Expressed concern over one of the terms being so long as an appointed position versus voting on it.

Leslie Williams Crews- Leslie said that in regards to Mark's position, she knows everyone that is running, and that because it is a long term, she thinks that Kassidy Mankowski is the best person for the long term position. Leslie mentioned that Kassidy has 3 children that will be attending, Leslie spoke highly to Kassidy's qualities, and encouraged the board to consider her.

John Jerabek - He also recommended Kassidy Mankowski for the long term position.

Guinevere Nelson – She said that she would like to recommend that the board wait to appoint the other two positions, giving the community further time to submit letters of interest. John Howard spoke to that, saying that the compromise between himself and Damon was only to appoint two positions today. John stated that he would have preferred to appoint all three, Damon Gibbons only wanted to fill Mark Tiley's vacant position, and the compromise was appointing two members today.

Craig Twite said that he would like to see the board members spread out, meaning that they weren't all parents. He stated that other members of the community could benefit the school.

### **E. OPENING COMMENTS**

President John Howard discussed the board vacancies. He stated that both he and Damon Gibbons had contact with the Board's attorney regarding moving forward to appoint board members with only two members currently on the board. John Howard clarified that Mark Tiley's term is up on November 2021, but Eryn Wintz's and Melanie Freedle's terms are up on November 2019.
